

INSTALLATION STEPS

- Remove any contents in the vehicle's rear compartment where mounting holes will be drilled. Mark the
 vehicle's centerline at underside of rear bumper. Hold the hitch in place centered and square on vehicle.
 Position the hitch for hitch ball to bumper clearance of 1 1/2" minimum. Mark and trim bumper fascia on
 some models.
- 2. Hold the hitch in place under the vehicle and use hitch as a template to mark floor and bumper for drill holes. Drill holes in bumper beam for 7/16" fasteners and drill holes in trunk floor for 3/8" fasteners. Work (2) u-bolts into bumper by slowly sliding into one hole until it sticks out of adjacent hole. Install fasteners as shown. Be careful not to push U-bolts out of position when putting hitch into place.
- 3. Torque all 3/8" fasteners to 45 lb.-ft and all 7/16" fasteners to 70 lb.-ft.
- 4. Use silicone sealant to seal hardware installed through trunk floor.
- 5. Reinstall all contents removed in Step 1.
